Appropriate Body Service Pricing

All schools that offer a statutory induction are required to have an Appropriate Body (AB) for their Early Career Teachers (ECTs). ABs play a key role in statutory teacher induction. In addition to monitoring that ECTs receive their statutory entitlements, ABs will support schools and ECTs to meet the statutory guidance.

Options

Full Induction Programme £195 per ECT per year

- Full access to OneCornwall TSH AB services.
- AB registration of ECTs on the TRA system.
- Regular checks of monitoring reports and formal assessment points at the end of year 1 and 2 of induction.
- Additional support for ECTs not meeting Teachers' Standards.

Full Induction Programme – (with another national provider not through OneCornwall) £240 per ECT per year

- Full access to OneCornwall TSH AB services.
- AB registration of ECTs on the TRA system.
- Regular checks of monitoring reports and formal assessment points at the end of year 1 and 2 of induction.
- Additional support for ECTs not meeting Teachers' Standards.

Core Induction Programme £500 per school Quality Assurance + £195 per ECT per year

- Fidelity check before the start of the induction period by the AB ensuring induction meets the ECF induction programme standards.
- AB registration of ECTs on the TRA system.
- Ensure ECTs are fairly and regularly assessed through collection of monitoring reports and formal assessment points at the end of both years of induction and interim points.
- Quality assure the schools detailed breakdown of the programme for years 1 and 2.
- Additional observation(s)/quality assurance of ECF induction programme throughout the two years.
- Additional support for ECTs not meeting Teachers' Standards.

School led Programme

£1000 per Quality Assurance + £195 per ECT per year

- AB to register ECTs on the TRA system.
- Fidelity check before the start of the induction period by the AB. Checks will ensure:
 - ECTs receive a programme of support and training based on the ECF induction programme;
 - The induction's design covers the evidence-based statements in the ECF; and
 - ECTs have received planned elements of the induction.
- Quality Assurance visits to ensure the materials and sessions are in line with the statutory guidance for induction.
- Ensure ECTs are fairly and regularly assessed at the end of year 1 and 2 of induction and at interim points.
- Additional observation(s)/quality assurance of ECF school-designed programme throughout the two years.
- Quality assure the schools detailed breakdown of the programme for years 1 and 2.
- The AB will use desktop reviews, observations and interviews with ECT.
- Additional support for ECTs not meeting Teachers' Standards.
